

Parent Application Instructions

Hello! We are happy that you are considering the Southern Nevada Urban Micro Academy. The Southern Nevada Urban Micro Academy offers two options for your child.

Option 1 is the Academy's homeschooling coop program. This program is for homeschooled children. If you have not already filed a Notice of Intent to Homeschool with CCSD, you must submit this notice. This program provides in-person education assistance and support to your child and gives your child access to nationally-recognized online educational programs.

Option 2 is the Academy's CCSD program. This program provides in-person education support for children who are enrolled in a CCSD school.

Option 1 - The Academy's Homeschooling Coop Program

To be homeschooled, parents/guardians must file a completed [Declaration of Intent to Homeschool form](#) pursuant to NRS 388D.020. In doing so, the parent/guardian officially un-enrolls their child from their prior school and declares that the parent/guardian has control or charge of the child and the legal right to direct the education of the child and assumes full responsibility for the education of the child while the child is being homeschooled. It is important to understand that if your prior school was a magnet school or a charter school, your child might lose their place in that school and have to enter the lottery to re-enroll. You should also include an education plan with your completed Intent to Homeschool form. If you elect to enroll your child in Option 1, here is a sample education plan you can consider using:

Educational Plan:

The educational plan for my child will include sending my child to participate in the Southern Nevada Urban Micro Academy every weekday, where my child will use NSSI curriculum (for grades 3-8) or Prenda curriculum (grades 1-2) for the core subjects of math and ELA and, which will also include reading, writing, and composition. The Southern Nevada Urban Micro Academy will also provide social studies, science and other curricula as well.

We recommend sending the Notice of Intent to Homeschool; via certified mail or any method where you receive confirmation of delivery. You will likely not receive any confirmation or acknowledgement from the CCSD office. Once they have been notified, you are official and clear to attend our Academy program.

Your child will have access to a computer during the entire day.

The Academy has access to the NSSI curriculum for grades 3-8 and Prenda for grades 1-2. Children who are in Kindergarten must be part of the CCSD option. There will be enrichment activities provided, which include dance, yoga, DuoLingo (foreign language program), and more.

There will be recreational activities provided for your child. Breakfast will be provided for all children arriving before 8:25 a.m. and lunch will be provided for all children.

Option 2 - The Academy's CCSD Program

If your child has a CCSD device, please have your child bring their CCSD device each day. Do not bring personal devices.

Your child will have access to a computer during their scheduled CCSD classroom time. You will need to let us know the times that your child's teacher has scheduled. If your child's teacher changes their schedule, it is your responsibility to let us know if the schedule changes.

We cannot guarantee that your child will have access to the computer to do all of their required schoolwork during the day. Your child will likely have work to complete at home.

There will be recreational activities provided for your child. Breakfast will be provided for all children arriving before 8:25 a.m. and lunch will be provided for all children.
