**ORDINANCE NO. 2600** AN ORDINANCE AUTHORIZING THE ISSUANCE OF THE CITY OF NORTH LAS VEGAS, NEVADA, GENERAL OBLIGATION (LIMITED TAX) MEDIUM-TERM BONDS, SERIES 2011 (QUALIFIED ENERGY CONSERVATION BONDS), FOR THE PURPOSE OF ACQUIRING, CONSTRUCTING, IMPROVING AND EQUIPPING BUILDING PROJECTS FOR THE CITY; AND PROVIDING DETAILS CONCERNING THE BONDS AND THE PROJECT; AND PROVIDING OTHER MATTERS RELATING THERETO.

**ORDINANCE NO. 2544** AN ORDINANCE RELATED TO ZONING; AMENDING SECTION 010 OF CHAPTER 16 OF TITLE 17 OF THE CITY OF NORTH LAS VEGAS MUNICIPAL CODE BY RECLASSIFYING APPROXIMATELY 1,333.39+/- ACRES THEREIN FROM AN O-L, OPEN LAND DISTRICT TO A PSP, PUBLIC/SEMI-PUBLIC DISTRICT (ZN-04-10, NORTH LAS VEGAS READINESS CENTER), FOR PROPERTIES GENERALLY BOUNDED BY GRAND TETON DRIVE ALIGNMENT TO THE NORTH, HOLLYWOOD BOULEVARD TO THE EAST, NELLIS BOULEVARD ALIGNMENT TO THE WEST AND CENTENNIAL PARKWAY ALIGNMENT TO THE SOUTH, AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

**ORDINANCE NO. 2601** AN ORDINANCE RELATED TO ZONING; AMENDING SECTION 010 OF CHAPTER 16 OF TITLE 17 OF THE NORTH LAS VEGAS MUNICIPAL CODE OF THE CITY OF NORTH LAS VEGAS BY AMENDING A PREVIOUSLY APPROVED 22.9+/- ACRES MUD, MIXED-USE DEVELOPMENT DISTRICT / COMMUNITY CENTER MIXED USE (ZN-54-06, CRAIG & ALLEN MUD AMENDMENT) BY MODIFYING THE SITE PLAN FOR THE COMMERCIAL COMPONENT LOCATED AT THE SOUTHWEST CORNER OF CRAIG ROAD AND ALLEN LANE; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO.

AN ORDINANCE OF THE CITY OF NORTH LAS VEGAS AMENDING ORDINANCE NO. 1747 OF THE NORTH LAS VEGAS MUNICIPAL CODE TO AMEND TITLE 5, CHAPTER 5.02 OF THE NORTH LAS VEGAS MUNICIPAL CODE; AMENDING SECTIONS 5.02.001, 5.02.035, 5.02.040, 5.02.130, AND 5.02.390 AND ADDING A NEW SECTION 5.02.027; PROVIDING DEFINITIONS REGARDING MULTI-JURISDICTIONAL LICENSES; ESTABLISHING LICENSING PROVISIONS FOR MULTI-JURISDICTIONAL LICENSES; REVISING CERTAIN PROVISIONS RELATING TO CONTRACTORS; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.
