The City of North Las Vegas (City) is requesting bid proposals for the following Project:

DETENTION CENTER DORMITORIES A, B, AND F ROOF RENOVATION

SCOPE OF WORK:

The site for the work is the City of North Las Vegas Detention Center Dormitories A, B, and F located at 2332 N. Las Vegas Blvd. The work generally involves providing all materials, labor, and supervision necessary for the renovation of the roofs at the Detention Center Dormitories A, B, and F and other accessories pertaining thereto.

The Project shall be completed within sixty (45) consecutive calendar days from the date specified in the Notice-to-Proceed, which time shall include resolution of all punch list items, final cleanup and demobilization.

A MANDATORY PREBID CONFERENCE AND SITE WALK THROUGH will be held on Tuesday, June 23, 2009, at 10:00 a.m. in the City Council Chambers, City Hall Complex, 2200 Civic Center Drive, North Las Vegas, NV 89030. The purpose of this conference is to discuss the Project, prospective bidders concerns, and key issues. The prebid site walk though will immediately following the prebid conference at the project site, 2332 N. Las Vegas Blvd., North Las Vegas, NV 89030. The purpose of the site walk through is to allow prospective bidders the opportunity to examine the project location and raise any concerns or issues **The Prebid Conference and Site Walk Through are mandatory. Bids received from firms not represented at the Mandatory Prebid Conference and Site Walkthrough will not be considered and will be returned unopened.** For special assistance or accommodations at this pre-bid conference, please contact the ADA coordinator at (702) 633-1510 at least 72 hours in advance.

BID OPENING: All Bids must be submitted in a sealed envelope, plainly marked, as detailed in Paragraph E, of the Instructions to Bidders, Section IB.1. All bids must be received in the office of the City Clerk, City Hall Complex, 2200 Civic Center Drive, North Las Vegas, NV 89030, prior to 2:00 p.m., local time, on Tuesday July 7, 2009. The official time will be per the City Clerk's office without exception. Bids received and stamped after the designated time will not be considered and will be returned to the Bidder unopened. Bids will be publicly opened and read aloud in the City Council Chambers, City Hall Complex, immediately after the established closing time and date. BID DOCUMENTS will be available on Wednesday, June 17, 2009 and may be obtained Monday through Thursday, at the Public Works Department, Engineering Division, 2266 Civic Center Drive, North Las Vegas, NV 89030, for a non-refundable fee of \$25.00. The Bid Documents can also be retrieved through DemandStar.com. If documents are to be mailed, there will be a \$25.00 postage and handling fee. Bidders for this Work must be qualified and properly licensed for this particular work by the Nevada State Contractor's Board, and licensed to do business in the City of North Las Vegas prior to the award of Bid by City Council. Failure to comply will result in rejection of the Bid. Nevada Contractor's License classification, number, and dollar limit must be indicated on the Bid Proposal. Questions concerning license requirements

shall be directed to the Nevada State Contractor's Board. Bidders and the successful Contractor and Subcontractors shall comply with all provisions of Nevada Revised Statutes (NRS) Chapter 624 and Nevada Administrative Code, Chapter 624.


Bids shall be submitted in a sealed envelope, plainly marked with the bidder's name and address in the lower left-hand corner, the bid number, the opening date and time, and accompanied by the sealed Bid Proposal, Bid Schedule, Subcontractor Listing, Suppliers Listing, Bid Preference Certificate of Eligibility (if applicable), Bid Bond, Non-Collusive Affidavit, and Americans with Disabilities Statement.

The City Council of the City of North Las Vegas reserves the right to reject any or all bids or waive any informality in a bid. No bidder may withdraw his bid for a period of 90 days after the date set for the opening thereof. Acceptance, rejection, and other requirements of bidders are subject to the NRS Chapter 338, as amended.

The City is an Equal Opportunity Employer and women-owned and minority business enterprises are strongly encouraged to bid.
