**Submittal Requirements:**

- Completed *Stockpile Plan Submittal Application*
- Three (3) copies of the stockpile plan, wet-stamped and signed by the engineer
  - Stockpile must not exceed 6-feet in height with cross section through the stockpile provided
  - Stockpile must be located at least 100-feet away from all property lines and right-of-way
  - Existing contour lines must be shown and the stockpile must avoid placement within a wash
  - There must be pave access provided to the stockpile location
- Signed, original letter from the owner/developer that includes the following information:
  - Statement of necessity for the stockpile
  - Estimate of the time to complete the stockpile activities and duration of the stockpile
  - Acknowledgment that the owner/developer will not seek construction permits for work outside the scope of the stockpile plan prior to approval of the associated civil improvement plans (if applicable)
  - Certification that the developer's intention is to stockpile only, that no compacting or spreading of material will occur and that all stockpiled material will be required to be moved again during the engineered fill process that is monitored by a geotechnical observer
- Notarized letter of permission from property owner(s) for any proposed stockpile placement on property not owned by the applicant.
