## EXPLORER APPLICATION PROCESS

Welcome to the North Las Vegas Police Explorer Program.

Attached you will find three forms that you are required to complete in order to process your application for police Explorer.

1. **Application Form:**

The application is information about you, the potential Explorer. It allows us information as to your residence and history previous to your affiliation with the North Las Vegas Police Department. Please complete all areas. If you come to an area that no information is possible to obtain or does not apply, please put "N/A" in that area.

2. **Release of Information/Waiver Form:**

This form is required to be able to conduct a background investigation. It is also required that the form be notarized. If you are under 18 years of age, a parent is required to sign it as well.

3. **Media Waiver Form:**

This form is required in order for us, the Police Department, to be able to take any photographs of you and use them in any advertising, posters, pamphlets or any other type of media. It must be signed by the parents if the Explorer applicant is under 18 years of age. Should the Explorer applicant be 18 years or older it may be signed by the Explorer applicant and the Explorer applicants' age must be placed next to the signature.

Please fill these forms out as soon as possible. It is imperative that they be returned to the Explorer Coordinator so the final processes can be done without delay.

Information of a confidential or privileged nature may be included.

Nevada Revised Statutes 239B, requires any current or previous employer to release any and all information to the Law Enforcement Agency regarding a current or former employee. This includes but is not limited to evaluations, attendance, disciplinary actions and rehire eligibility. Information released is strictly confidential and the employer is immune from Civil Liability for such disclosure and its consequences.

Furthermore, I hereby release you, your organization and others of any and all liability or damage which may result by furnishing the information requested by the above-named organization on my behalf.

It is my desire that a photocopy reproduction of this authorization have the same force and effect as the original.

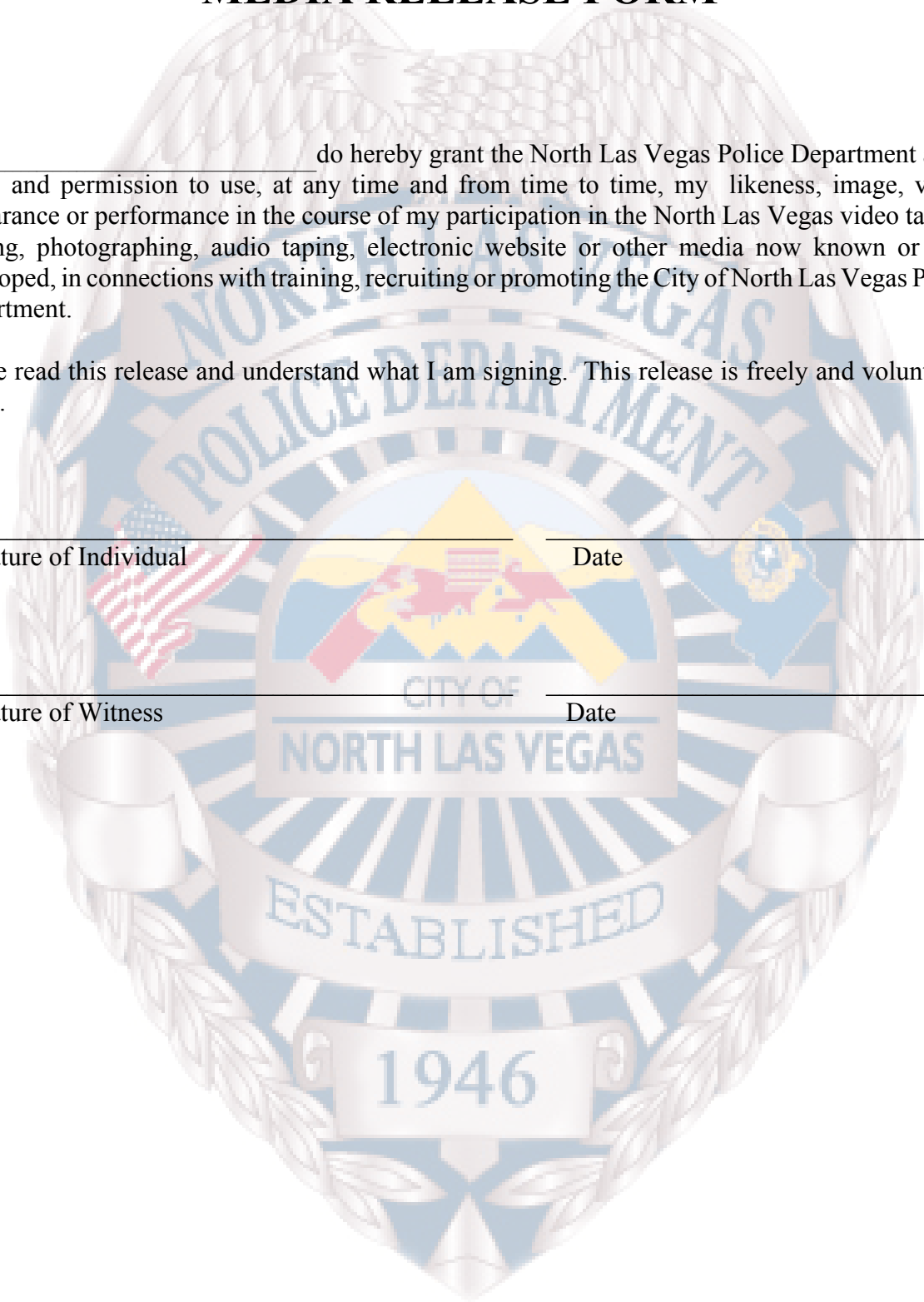
