The City of North Las Vegas (City) is requesting bid proposals for the following Project:

**CRAIG RANCH REGIONAL PARK RAILROAD**

**SCOPE OF WORK:** The work generally consists of labor, materials, and transportation, including fuel, power, water, and all appurtenant work necessary for the installation of owner provided existing track. The railroad improvements include installation of rail, switches, railroad ties, gravel base, hardscape amenities and other necessary appurtenances required to complete and create a serviceable project.

The Project shall be completed within **ninety (90) consecutive calendar days** from the date specified in the Notice to Proceed, which time shall include resolution of all punch list items, final cleanup and demobilization.

The estimated monetary range of the project is: **\$650,000 to \$750,000.**

**A PREBID CONFERENCE** will NOT be held for this project. All questions must be submitted in writing and received no later than 3:00 p.m., Thursday, October 7, 2021.

**BID OPENING:** Bids shall be submitted via mail, FedEx, hand delivered (if available), or other similar shipping method. A delivery service with verification of delivery is recommended. All bids must be received by the City Clerk prior to the close of business on **Monday, October 18, 2021**. All Bids must be submitted in a sealed envelope, plainly marked, as detailed in Paragraph E, of the Instructions to Bidders, Section IB.1. If shipped, the sealed envelope containing the Bid Proposal shall be enclosed in another envelope (the shipping envelope) addressed to the office of the City Clerk, City Hall, 2250 Las Vegas Blvd. North, Suite 800 (8<sup>th</sup> Floor), North Las Vegas, NV 89030. Bids received and stamped after the designated time will not be considered and will be returned to the Bidder unopened. A public bid opening will not be held for this project. Bids will be opened at 10:00 a.m. on Tuesday, October 19, 2021 by the City Clerk and witnessed by the Public Works project manager. Apparent bid results will be sent via email to the address provided on Page BP-7 of the bid proposal. The final 1% subcontractor list shall be included in the bid proposal or submitted via email within two hours of notification of apparent bid results.
