The City of North Las Vegas (City) is requesting bid proposals for the following Project:

**NORTHEAST INTERCEPTOR PROJECT PHASE I**

**SCOPE OF WORK:**

The Work to be performed under this Contract shall consist of the furnishing of all labor, materials, and transportation, including fuel, power, and water, and all appurtenant Work necessary for the acceptable construction of a new interceptor sewer varying in size from: 42-inch pipe, 36-inch pipe, 24-inch pipe, and 12-inch pipe. The new interceptor sewer construction begins at the junction structure in the intersection of Betty Lane and Alto Avenue and proceeds North in Betty Lane to East Cheyenne Avenue, then west in East Cheyenne Avenue to North Nellis Boulevard, then north in North Nellis Boulevard to North Las Vegas Boulevard, then northeast in North Las Vegas Boulevard to a point located approximately 2,300-linear feet north east of the Las Vegas Boulevard and Craig Road intersection. At the terminus point of the sewer, the sewer shall be capped. Along with the sewer interceptor pipeline, this project also consists of pavement removal and replacement, replacement of affected medians, median landscaping curb, gutter, sidewalk, signage, pavement markings, and all other appurtenances as required.

The Work in this Contract also includes roadway improvements within North Las Vegas Boulevard from the intersection of Nellis Boulevard to 600-feet past the intersection of Craig Road. These improvements have been designed by the Nevada Department of Transportation (NDOT) and are included as part of this Contract and Work. The North Las Vegas Boulevard roadway improvements consists of: mill and overlay of plantmix bituminous surface, installation of new plantmix bituminous surface, utility valve and manhole rim adjustments to finished grade, installation of new median island and associated curbing as well as removal and replacement of existing median island and associated curbing, installation of decorative rock and stamped concrete within median islands, permanent roadway striping, and traffic sign installation.

The Project shall be completed within **three hundred thirty-six (336) consecutive calendar days** from the date specified in the Notice to Proceed, which time shall include resolution of all punch list items, final cleanup and demobilization.

The estimated monetary range of the project is: **\$17,500,000 to \$18,500,000.**

**A PREBID CONFERENCE** will be held on **May 16, 2017**, at **2:00 p.m.** in Room 630, City Hall, 2250 Las Vegas Blvd. North, Suite 610 (6<sup>th</sup> Floor), North Las Vegas, NV 89030. The purpose of this conference is to discuss the Project, prospective bidders' concerns, and key issues. **Although the meeting is not mandatory, perspective bidders are encouraged to attend.** For special assistance or accommodations at this bid opening, please contact the ADA coordinator at (702) 633-1501 or TDD (800) 326-6868 at least 72 hours in advance.

**BID OPENING:** All Bids must be submitted in a sealed envelope, plainly marked, as detailed in Paragraph E, of the Instructions to Bidders, Section IB.1. All bids must be received in the office of the City Clerk, City Hall, 2250 Las Vegas Blvd. North, Suite 800 (8<sup>th</sup> Floor), North Las Vegas, NV 89030, prior to **10:00 a.m.**, local time, on **Wednesday, May 24, 2017**. The official time will be per the City Clerk's office without exception. Bids received and stamped after the designated time will not be considered and will be returned to the Bidder unopened. Bids will be publicly opened and read aloud in Room 630, City Hall, 2250 Las Vegas Blvd. North, Suite 610 (6<sup>th</sup> Floor), North Las Vegas, NV 89030, immediately after the established closing time and date. The non-refundable fee for printed copies is \$150. If documents are to be mailed, there is a \$75 postage and handling fee. Only checks can be accepted and are to be made payable to the City of North Las Vegas.

Bidders for this Work must be qualified and properly licensed for this particular Work by the Nevada State Contractor's Board, and licensed to do business in the City of North Las Vegas prior to the award of Bid by City Council. Failure to comply will result in rejection of the Bid. Nevada Contractor's License classification, number, and dollar limit must be indicated on the Bid Proposal. Questions concerning license requirements shall be directed to the Nevada State Contractor's Board. Bidders and the successful CONTRACTOR and Subcontractors shall comply with all provisions of Nevada Revised Statutes (NRS) Chapter 624 and Nevada Administrative Code, Chapter 624.

Bids shall be submitted in a sealed envelope, plainly marked with the bidder's name and address in the lower left-hand corner, the bid number, the opening date and time, and accompanied by the sealed Bid Proposal, Bid Schedule, Subcontractor Listing, Suppliers Listing, Bid Preference Certificate of Eligibility (if applicable), Bid Bond, Non-Collusive Affidavit, and Americans with Disabilities Statement.

The City Council of the City of North Las Vegas reserves the right to reject any or all bids or waive any informality in a bid. No bidder may withdraw his bid for a period of one hundred twenty (120) days after the date set for the opening thereof. Acceptance, rejection, and other requirements of bidders are subject to the NRS Chapter 338, as amended.

The City is an Equal Opportunity Employer and women-owned and minority business enterprises are strongly encouraged to bid.
