The City of North Las Vegas (City) is requesting bid proposals for the following Project:

ADA SIDEWALK ACCESSIBILITY FISCAL YEAR 16/17

SCOPE OF WORK:

The work generally involves removal of existing concrete curb, gutter, spandrels, tactile warning panels/truncated domes, and sidewalk. The areas removed will be replaced with ADA accessible concrete ramps, curb, gutters, spandrels, and sidewalk that include tactile warning panels along with appurtenant street improvements. The work performed shall comply with the Department of Justice (DOJ) CFR, 28CFR, p. 36, rev. 7/1/94.

The Project shall be completed within ninety (90) consecutive calendar days from the date specified in the Notice-to-Proceed, which time shall include resolution of all punch list items, final cleanup, and demobilization.

The Project is federally funded subject to Davis-Bacon and Section 3 Regulations, as well as State Prevailing Wage. The Contractor shall pay each employee the higher rate of either the Clark County Prevailing Wage Rates and the Davis-Bacon Wage Rates at each trade position.

A PREBID CONFERENCE will be held on Tuesday, December 19, 2017, at 11:00 a.m., local time, at North Las Vegas City Hall, 2250 Las Vegas Blvd. North, Suite 610 (6th Floor), Room 630, North Las Vegas, NV 89030. The purpose of this conference is to discuss the Project, prospective bidders concerns, and key issues. **Although the meeting is not mandatory, prospective bidders are encouraged to attend.** For special assistance or accommodations at this bid opening, please contact the ADA coordinator at (702) 633-1501 or TDD (800) 326-6868, at least 72 hours in advance.

BID OPENING: All Bids must be submitted in a sealed envelope, plainly marked, as detailed in Paragraph E, of the Instructions to Bidders, Section IB.1. All bids must be received in the office of the City Clerk located in North Las Vegas City Hall, 2250 Las Vegas Blvd. North, Suite 800 (8th Floor), North Las Vegas, NV 89030, prior to 2:00 p.m., local time, on Tuesday, January 9, 2018. The official time will be per the City Clerk's office without exception. Bids received and stamped after the designated time will not be considered and will be returned to the Bidder unopened. Bids will be publicly opened and read aloud at North Las Vegas City Hall, 2250 Las Vegas Blvd. North, Suite 610 (6th Floor), Room 630, North Las Vegas, NV 89030, immediately after the established closing time and date. Bidders for this Work must be qualified and properly licensed for this particular work by the Nevada State Contractor's Board, and licensed to do business in the City of North Las Vegas at the time of the Bid Opening. Failure to comply will result in rejection of the Bid. Nevada Contractor's License classification, number, and dollar limit must be indicated on the Bid Proposal. Questions concerning license requirements shall be directed to the Nevada State Contractor's Board. Bidders and the successful Contractor and Subcontractors shall comply will all provisions of Nevada revised Statues (NRS) Chapter 624 and Nevada Administrative Code, Chapter 624.

Bids shall be submitted in a sealed envelope, plainly marked with the bidder's name and address in the lower left-hand corner, the bid number, the opening date and time, and accompanied by the sealed Bid Proposal, Bid Schedule, 5% Subcontractor List, Material Supplier List, Bid Security, Certificate of Eligibility (if applicable), Public Works Bidder's Preference Affidavit (if applicable), Bid Bond, Non-Collusive Affidavit of Prime Bidder, Americans with Disabilities Act, HUD-4010 Form, Affidavit of Non-Debarred Status, Section 3 Acknowledgement and Certification, Section 3 Assurance, Hiring/Employee Utilization Plan, Subcontractor Activity Report and Acknowledgement of Section 3 Clause.

The City of North Las Vegas Council reserves the right to reject any or all bids or waive any informality in a bid. No bidder may withdraw his bid for a period of 90 days after the date set for the opening thereof. Acceptance, rejection, and other requirements of bidders are subject to the NRS Chapter 338, as amended.

The City is an Equal Opportunity Employer and women-owned and minority business enterprises are strongly encouraged to bid.
