The City of North Las Vegas (City) is requesting bid proposals for the following Project:

SCOPE OF WORK: Remodel of two shower areas in the C Dormitory. The Project shall be completed within **ninety (90) consecutive calendar days** from the date specified in the Notice to Proceed, which time shall include resolution of all punch list items, final cleanup and demobilization.

The estimated monetary range of the project is **\$250,000 to \$350,000**.

A MANDATORY PREBID CONFERENCE will be held on **Thursday, January 23, 2020, at 9:00 a.m.** behind (east of) the City's building at 2200 Civic Center Drive, North Las Vegas, NV 89030. The purpose of this conference is to discuss the Project, prospective bidders concerns, and key issues. **THIS PREBID CONFERENCE IS MANDATORY. BIDS RECEIVED FROM FIRMS NOT REPRESENTED AT THE MANDATORY PREBID CONFERENCE WILL NOT BE CONSIDERED AND WILL BE RETURNED UNOPENED.**

BID OPENING: All Bids must be submitted in a sealed envelope, plainly marked, as detailed in Paragraph E, of the Instructions to Bidders, Section IB.1. All bids must be received in the office of the City Clerk, City Hall, 2250 Las Vegas Blvd. North, Suite 800 (8th Floor), North Las Vegas, NV 89030, prior to **2:00 p.m., local time, on Thursday, January 30, 2020**. Bids received and stamped after the designated time will not be considered and will be returned to the Bidder unopened. Bids will be publicly opened and read aloud in Room 630, City Hall, 2250 Las Vegas Blvd. North, Suite 610 (6th Floor), North Las Vegas, NV 89030, immediately after the established closing time and date.
