The City of North Las Vegas (City) is requesting bid proposals for the above Project.

SCOPE OF WORK:


Construction of half street improvements along Hammer Lane, between Flying Arrow Place and Simmons Street. The improvements primarily consist of roadway excavation, base course installation, asphalt pavement placement, concrete flatwork, pavement markings, and other associated appurtenances. The Project shall be completed within ninety (90) consecutive calendar days from the date specified in the Notice to Proceed, which time shall include resolution of all punch list items, final cleanup and demobilization. The estimated monetary range of this project is **\$250,000 to \$350,000**.

A PREBID CONFERENCE will **NOT** be held for this project. Bidders are expected to familiarize themselves with the project site and conditions without the attendance of City representatives.

BID OPENING: All Bids must be submitted in a sealed envelope, plainly marked, as detailed in Paragraph E, of the Instructions to Bidders, Section IB.1. All bids must be sent by First Class Mail, UPS, FedEx, other suitable mail service with tracking, or hand delivered and be received in the office of the City Clerk, City Hall, 2250 Las Vegas Boulevard North, Suite 800 (8th Floor), North Las Vegas, NV 89030, prior to close of business on Monday, February 22, 2021. Bids received and stamped after the designated time will not be considered and will be returned to the Bidder unopened. Bids will be opened at 10:00 a.m. on Tuesday, February 23, 2021 by the City Clerk's Office and witnessed by Public Works personnel. Apparent bid results will be sent to the email address provided by the prospective bidders on the signature page of the Bid Proposal. The 1% Contractors List in the Bid Proposal may be provided with the bid package submittal or within 2-hours after the City's email notification of the three (3) apparent low bidders.

BID DOCUMENTS will be available electronically beginning Tuesday, February 9, 2021 on both the NGEM System and Demandstar.com for a nominal fee with the vendor.
