The City of North Las Vegas (City) is requesting bid proposals for the above named Project:

SCOPE OF WORK: The work involves construction of pedestrian safety enhancements, landscaping, parklet, sidewalk and curb ramp upgrades, pavement widening, new medians, signing/stripping, and other related appurtenances. The improvements are located at three North Las Vegas Schools: Brian and Teri Cram Middle School; Addeliar D Guy Elementary School; and HP Fitzgerald Elementary School

The Project shall be completed within **ninety (90) consecutive calendar days** from the date specified in the Notice to Proceed, which time shall include resolution of all punch list items, final cleanup and demobilization.

The estimated monetary range of the project is: **\$1,600,000 to \$2,000,000.**

A PREBID CONFERENCE will NOT be held for this project. Any question should be submitted to David Tanner, Senior Engineer, City of North Las Vegas, by email at tannerd@cityofnorthlasvegas.com. All questions must be submitted in writing and received no later than 3:00 p.m., Thursday, December 2, 2021.

BID OPENING: All Bids must be submitted in a sealed envelope, plainly marked, as detailed in Paragraph E, of the Instructions to Bidders, Section IB.1. All bids must be received in the office of the City Clerk, City Hall, 2250 Las Vegas Blvd. North, Suite 800 (8th Floor), North Las Vegas, NV 89030, prior to close of business on **Monday, December 13, 2021**. Bids received and stamped after the designated time will not be considered and will be returned to the Bidder unopened. A public bid opening will not be held for this project. Bids will be opened at 11:00 a.m. on Tuesday, December 14, 2021 by the City Clerk and witnessed by a Public Works representative. Apparent bid results will be sent via email provided on Page BP-7 of the bid proposal. The final 1% subcontractor list shall be included in the bid proposal or submitted via email within two hours of notification of apparent bid results.

BID DOCUMENTS will be available for download beginning **Wednesday, November 10, 2021** on the NGEN System and Demandstar.com for a nominal fee with the vendor. For more information on bid documents please email schaeferc@cityofnorthlasvegas.com.

This is a Federal-Aid project so any contractor, otherwise qualified by the State of Nevada to perform such work, is not required to be licensed nor to submit application for license in advance of submitting a bid or having such bid considered. However, the contractor determined to be the successful bidder shall obtain the required license in accordance with the provisions of NRS Chapter 624 prior to executing the contract.
