Addendum No. 1**

The deadline for questions for this proposal was 12:00 p.m., Monday, August 27, 2018. The following are the questions that were received and answers to those questions. Also attached is a copy of the sign in roster from the Pre Bid meeting conducted on August 20, 2018. A copy of this addendum must be signed and returned with your proposal.

Question 1. Are there specifications for the type of Armored Vehicles to be used for transport? *Answer: The successful respondent shall utilize an armored vehicle to transport the items described herein. Vehicles used for this service shall be owned and operated by the respondent at the respondent's expense. No standard street vehicles such as non-armored automobiles, vans, light trucks, pick-up trucks or motorcycles shall be used.*

Question 2. Will "Contractor Badges" be used by the provider? *Answer: We will determine that with the selected vendor during contract negotiations.*

Question 3. Who provides the coin and deposit bags? *Answer: The City will provide deposit bags and coin wrappers.*

Question 4. Do you require the provider to be in uniform or can they wear low-profile clothing? *Answer: The successful respondent will provide armed, uniformed, bonded and properly licensed guards who have been trained and licensed to carry firearms and are experienced in armored car pick-up and delivery service, as specified in NRS 648.013.*

Question 5. Is same day service absolutely necessary? It is substantially less efficient operationally and more expensive. *Answer: All scheduled pick-ups shall be delivered to banks no later than close of business that same day. However, all short-notice, unscheduled pick-ups do not have to have same day service.*

Question 6. Is Wells Fargo the only delivery location? *Answer: No, the City is in the process of switching banks from Bank of America to Wells Fargo and maintains accounts at both locations. We expect the transition to be completed around January 1, 2019.*

Question 7. Can we get a copy of the current contracts original Bid submittal? *Answer: Yes, a copy is attached to the end of this Addendum.*
