Question 1. Did the Scope of Work change in this new bid?

Answer: Yes

Question 2. Why did the Scope of Work change?

Answer: Additional facilities and requirements were added.

Question 3. What was the contract amount spent last year?

*Answer: Last year the City spent approximately \$700K with Cypress security. **NOTE:** Caution, the scope of work described in the existing agreement and the proposed Bid are different. The existing Cypress agreement should not be used as the sole basis for your proposed bid.*

Question 4. Is the awarded company to provide all required equipment?

Answer: Yes.

Question 5. Do the other City facilities listed require armed security?

Answer: Yes, all positions in this bid are to be armed.

Question 6. In Section E (2) of the Scope of Work, it lists "One check performed randomly once per week" and "Plan for two fifteen (15) minutes checks per week". Which is it?

Answer: It will be two fifteen (15) minutes checks per week.

Question 7. How long will the term of the agreement be for?

Answer: The agreement will commence upon approval by City Council and execution of a contract. The length of the new agreement will be determined during contract development.

Question 8. Who is the incumbent?

Answer: Cypress Private Security.

Question 9. Was this the same vendor as before?

Answer: Yes, Cypress Private Security.
