The City of North Las Vegas (City) is requesting bid proposals for the above Project:


**SCOPE OF WORK:** Work shall include pavement rehabilitation and other work on Camino al Norte between Craig Road and Ann Road in North Las Vegas, Nevada 89031. The Project shall be completed within **two hundred ten (210) consecutive calendar days** from the date specified in the Notice to Proceed, which time shall include resolution of all punch list items, final cleanup and demobilization. The estimated monetary range of the project is **\$2,800,000 to \$3,200,000**.

**A PREBID CONFERENCE** will not be held for this project. Bidders are expected to familiarize themselves with the project site and conditions without the attendance of City representatives. Bidders are encouraged to contact the City's representative, Robert Huggins, P.E., with any questions or concerns.

**BID OPENING:** All Bids must be submitted in a sealed envelope, plainly marked, as detailed in Paragraph E, of the Instructions to Bidders, Section IB.1. All bids must be sent by mail service or hand delivered and be received in the office of the City Clerk, 2250 Las Vegas Blvd. North, Suite 800 (8<sup>th</sup> Floor), North Las Vegas, NV 89030, prior to **close of business on Wednesday, December 9, 2020**. Bids received after the designated time will not be considered and will be returned to the Bidder unopened. **A public bid opening will not be held. Bids will be opened at 10:00 a.m. on Thursday, December 10, 2020** by the City Clerk and witnessed by Public Works personnel. Apparent bid results will be sent via the email address provided by the prospective bidders on their signature page of the Bid Proposal. The 1% Contractors List as presented in the Bid Proposal may be provided with the Bid, or will need to be provided within 2-hours of the City's email notification of the three (3) apparent low bidders.
