The City of North Las Vegas (City) is requesting bid proposals for the subject Project:

SCOPE OF WORK: The work generally consists of the relocation of dry utility facilities, the restoration of all surface improvements, and all other appurtenances as required.

The Project shall be completed within **100 consecutive calendar days** from the date specified in the Notice to Proceed, which time shall include resolution of all punch list items, final cleanup and demobilization.

The estimated monetary range of the project is: **\$350,000 to \$380,000.**

A PREBID CONFERENCE will not be held for this project. Any question should be submitted to Clifford Moss, Senior Engineer, City of North Las Vegas, by email at mosscc@cityofnorthlasvegas.com. All questions must be submitted in writing and received no later than 12:00 Noon, Tuesday, March 16, 2021.

BID OPENING: Bids shall be submitted via mail, FedEx, hand delivered, or other similar shipping method. A delivery service with verification of delivery is recommended. All bids must be received by the City Clerk prior to the close of business on **Monday, March 22, 2021**. All Bids must be submitted in a sealed envelope, plainly marked, as detailed in Paragraph E, of the Instructions to Bidders, Section IB.1. The sealed envelope containing the Bid Proposal shall be enclosed in another envelope (the shipping envelope) addressed to the office of the City Clerk, City Hall, 2250 Las Vegas Blvd. North, Suite 800 (8th Floor), North Las Vegas, NV 89030. Bids received and stamped after the designated time will not be considered and will be returned to the Bidder unopened. A public bid opening will not be held for this project. Bids will be opened at 9:00 a.m. on Tuesday, March 23, 2021 by the City Clerk and witnessed by the Public Works project manager. Apparent bid results will be sent via email to the address provided on Page BP-6 of the bid proposal. The final 1% subcontractor list shall be included in the bid proposal or submitted via email within two hours of notification of apparent bid results.
