Rental Policies and Procedures: (Please initial after reviewing)

- It is the responsibility of the person reserving the area to advise their guest(s) of the Cabana Rental Policies and restroom locations. In addition, guests are not permitted to loiter in the parking lot area of the pool, nor interfere with pool operations.
- All pool rules and department refund policies apply.
- Setup and cleanup to be included in rental hours by rental applicants.
- Bring your own food, drinks, paper products and silverware.
- Alcohol and drug paraphernalia are prohibited, glass containers and sharp objects (including knives) are not permitted.
- DJ's food, use of barbeques and party decor must be approved in advance. (Music volume must be kept at a level that does not disturb.)
- The use of confetti and/or glitter are prohibited.
- Rentals are on a first-come, first-served basis and subject to availability.
 - Each rental must be booked a minimum of 14 days prior to the event.
- Pool area must be returned cleaned at the end of your event. If not, your Rental Cleaning Deposit may be forfeited.
- Cancellations (not less than an hour prior to end of the rental) due to weather or unavoidable circumstances will result in rescheduling. If rescheduling is not possible, a full refund will be issued.

The remaining balance for your rental is to be paid in full 2 weeks prior to your event.
