GENERAL

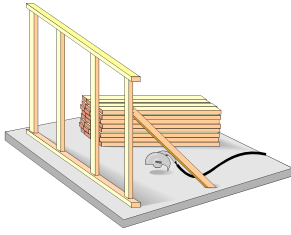
The following is **REQUIRED** by the City of North Las Vegas for Southern Nevada Health District (SNHD) approval prior to permit issuance:

The following are to be approved by Southern Nevada Health District. See additional information attached.

1. Underground Storage Tanks
2. Service Stations / Aboveground Fuel Tanks
3. Truck Wash / Car Wash Facilities
4. Paint Booths
5. Food Establishments (See additional information attached)

Once approval has been obtained from , a form provided by Southern Nevada Health District containing their approval and signature shall be returned to our office. This form must be returned prior to final approval and issuance of any permits from the city of North Las Vegas Permit Application Center.



This guide outlines the requirements for obtaining a permit for construction from the City of North Las Vegas.

- A) Please note that **one (1) separate application in PDF is** required to obtain construction permits from the City of North Las Vegas. **One (1) separate electronic set of plans submittals is** required.:
1. Permit Application Center (PAC): for building permits.
 2. Department of Public Works - Development and Flood Control Division - see attached applications and worksheets in the back of this package. For grading permits and civil plans approval.
- B) All plans submitted at the **online** will be routed to the necessary departments to be reviewed concurrently for conformance and compliance to all applicable codes and ordinances.
- C) Each department is responsible for their own review times, correction letters and approvals. You may receive more than one correction letter from different departments concerning a variety of questions or comments. Please respond to each department's correction/comment items individually.
- D) All plans shall be accompanied by a *completed application, subcontractor information sheet (when applicable), and electrical, mechanical and plumbing fixture count worksheets (when applicable).*

IN ORDER TO ENSURE THAT YOUR APPLICATION IS PROCESSED IN A TIMELY MANNER, PLEASE FOLLOW THE GUIDELINES HEREIN AND VERIFY YOUR SUBMITTAL PACKAGE IS COMPLETE.
